EDUCATION (ADE) PROGRAM FOR THE ACADEMIC YEAR 2017

The Accreditation/Registration/Certification/Renewal (ARCR) Committee of the Sindh Teacher Education Development Authority(STEDA) visited privately managed Teacher Training Institute, Notre Dame Institute of Education(NDIE) on 24/11/16 and evaluated the Institute on set standards for registration to offer Associate Degree in Education(ADE) program for the academic year 2017. The follow-up meeting of the committee was held on 20-12-2016 at STEDA office Karachi, it was unanimously decided that NDIE may be allowed provisionally to offer ADE Program, subject to following conditions.

1. NDIE will offer ONLY ADE program in its institution building, as the same was applied for registration.
2. NDIE is allowed 30 seats for admission
3. Vision and mission statement be shared with all stake holders
4. List of notified practicum schools (public and private) from their respective authorities and same be provided to STEDA before starting the classes.
5. Science lab should be separate, standard size and fully equipped.
6. Procedure for complaint and redressal should be in place.
7. Performance based award and recognition for faculty members.
8. Plan for staff welfare fund is to be placed.
9. The faculty members are to be appointed before starting particular semester; 1st Semester Sindhi, 2nd Semester Computer and Mathematics, 3rd Semester Arts and Crafts.

Subsequently on the bases of above recommendations, provisional registration is hereby accorded to Notre Dame Institute of Education(NDIE) to offer Associate Degree in Education(ADE) program for the academic year 2017. The STEDA, ARCR Committee may visit to Notre Dame Institute of Education (NDIE) at any time for verification of above conditions, in case of non-compliance the provisional registration will be cancelled.
